



GOLD ANNUAL PASS AGREEMENT

1. The Tangle Ridge Golf Club Gold Annual Pass Agreement is between Tangle Ridge Golf Club and the named holder(s) of the Gold Annual Pass. The named holder of the Gold Annual Pass agrees not to circulate the Gold Annual Pass to others.
2. The Tangle Ridge Gold Annual Pass will begin the day of full payment and will expire 365 days from date of purchase. The Tangle Ridge Gold Annual Pass will not be prorated throughout the year.
3. The Tangle Ridge Gold Annual Pass is non-transferable to any other individual. Refunds for the Tangle Ridge Gold Annual Pass will not be permitted.
4. The holder of the Tangle Ridge Gold Annual Pass agrees to follow all the rules of the Tangle Ridge Gold Annual Pass Agreement and the Rules and Regulations of Tangle Ridge Golf Club.
5. The management of Tangle Ridge Golf Club reserves the right to restrict or limit access to tee times and/or days or terminate any pass-holder who does not follow the Tangle Ridge Gold Annual Pass Agreement or the Rules and Regulations of Tangle Ridge Golf Club.
6. Full payment of **\$4,000** will be required at the time of purchasing a Tangle Ridge Gold Annual Pass.

 - ♦ The standard online "Booking Fee" will be applied if booking a tee time online.

The Holder of the Gold Annual Pass agrees not to hold Tangle Ridge Golf Club; the City of Grand Prairie, Texas; Mark Viskozki Golf Management, Inc.; and Tangle Ridge Bar & Grill, Inc. liable for any resulting bodily injury.
